Section 1 - General Information Regarding LSCB and SAB Training

Southend LSCB and SAB charge for most training with the exception of participants from voluntary/community or charity agencies who are offered special rates and some courses offered free of cost to all agencies (see course information for details). The LSCB or SAB will invoice your agency on completion of each course. The LSCB or SAB will also invoice your agency for the full cost of any course if a place has been allocated and you fail to attend or cancel your place without sufficient notice (7 working days) for the place to be allocated to another applicant. Your manager will be also informed if you fail to attend.

We do not allocate places on a first come first served basis. All face to face training is multi-agency and a mix of organisations is the priority. The number of places available will vary according to the course and venue. Confirmation of a place and joining instructions will be sent before the start of the training. **Please do not attend if you have not received a letter or email allocating you a place.**

It is expected that participants will attend for the whole of the course. Certificates will be issued only if the whole course has been attended

Section 2 - Target Groups for Safeguarding Children Training

Target Group 1

Those in infrequent contact with children, young people and/or parents/carers who may become aware of possible abuse or neglect (e.g. librarians, GP receptionists, community advice centre staff, groundsmen, recreation assistants, environmental health officers)

Target Group 2

Those in regular contact or have a period of intense but irregular contact, with children, young people and/or parents/carers including all health clinical staff, who may be in a position to identify concerns about maltreatment, including those that may arise from the use of the Early Help Assessment (e.g. housing, hospital staff, YOT staff and staff in secure settings, the police other than those in specialist child protection roles, sports development officers, disability specialists, faith groups, community youth groups, play scheme volunteers).

Target Group 3

Members of the workforce who work predominantly with children, young people and/or their parents/carers and who could potentially contribute to assessing, planning, intervening and reviewing the needs of a child and parenting capacity where there are safeguarding concerns (e.g. paediatricians, GPs, youth workers, those working in the early years sector, residential staff, midwives, school nurses, health visitors, sexual health staff, teachers, probation staff, sports club welfare officers, those working with adults in, for example, learning disability, mental health, alcohol and drug misuse services, those working in community play schemes)

Target Group 4

Members of the workforce who have particular responsibilities in relation to undertaking section 47 enquiries, including professionals from health, education, police and children's social care; and social work staff responsible for co-ordinating assessments of children in need.

Target Group 5

Professional advisers named and designated lead professionals.

Target Group 6

Operational managers at all levels including practice supervisors; front line managers; and managers of child protection units.

Target Group 7

Senior managers responsible for the strategic management of services; NHS board members.

Target Group 8

Members of the LSCB including: Board members, Independent Chair, Elected member, Lay members
